### ARMY GOLF ASSOCIATION (SOUTH EAST) 2019 ANNUAL GENERAL MEETING AND GOLF COMPETITION – 13 MAR 19

### General

1. The 2019 AGA (SE) Annual General Meeting and Golf Competition will be held at Test Valley Golf Club on Wed **13 Mar 19**.

## Eligibility

2. The meeting and competition is open to South East Region full or associate members of the Army Golf Association (AGA), who have an official Club or Society handicap. Non-members of the AGA may join on the day at the cost of £15.00 for one-year's membership.

## Format

3. **AGM**. The AGM will commence at 0945hrs. A separate agenda will be issued prior to this meeting.

4. **Golf Competition.** The format of the day will be 18 holes Stableford off full handicap allowance. Play will be from the white tees for gentlemen and red tees for ladies. Competition winner will be the individual with the most Stableford points over 18 holes (normal count back rules apply).

## Timings

5. The timings for the event are as follows

- b. 0930hrs AGM
- c. 1000hrs Final Registration
- d. 1036hrs 18 Hole Stableford
- e. TBC Prize giving

# Food

6. Coffee and Bacon Sandwich will be available from 0845hrs prior to the AGM. Food will be available after the round at **private expense**.

# Costs

7. Entry fees, which include green fees ( $\pounds$ 21), food ( $\pounds$ 4) and a contribution towards prizes ( $\pounds$ 5) will be payable by **CASH ONLY** on the day as follows:

- a. Members of Test Valley Golf Club £9.
- b. Non-members of Test Valley Golf Club £30.

## Prizes

8. The presentation of prizes will commence once all golfers have completed their round. All participants will be expected to attend the prize-giving.

9. Prizes will be awarded in the following order of precedence:

- a. 18 Hole Winner
- b. 18 Hole Runner-up.
- c. 18 Hole Third Place.
- d. Most Golf, Nearest the Pins (5<sup>th</sup> & 13<sup>th</sup>) and 2's (if you have entered)
